Workers who work a shift that is at least 6 hours long and lasts between 11 AM and 2 PM are entitled by New York labor laws about breaks to a half hour unpaid meal break for lunch. Workers who start work before 11 AM and end after 7 PM are entitled not only to their lunch break, but

an additional 20
minute meal break
between 5 and 7 PM.

New York Labor Laws Breaks - Employment

The PSLL applies to all private employers (and all employees) in New York State, but the level of required leave depends on an employer's size and net income. Certain very small employers will only have to

provide unpaid sick time. If an employer's existing sick leave or time-off policies meet the minimum requirements (including accrual, carryover, and use) of the Law, no additional sick leave needs to be provided.
